## Sub: Technical Sanction for NOFN Survey of Chincholi block in Gulbarga Dist.

Technical Sanction Final is hereby issued in respect of survey report of NOFN project submitted by **GMT Gulbarga** for Block **Chincholi**.

The observations on all 7 blocks of Gulbarga District was informed vide BBNL Letter No GM/BBNL/Bangalore/NOFN-survey/2 Dated 06/06/2013 and Technical sanction provisional was accorded to all blocks of Gulbarga District vide letter No GM/BBNL/Bangalore/NOFN-survey/25 Dated 18/09/2013 in order to expedite the tender.

Since the reply on design was of general nature and further by mapping the points to google earth it was suggested to keep the splitters at various locations for which SSA has agreed.

The details of the main parameters derived from survey report and L-14 diagram for the **Chincholi** block is given in the Annexure

The block comprises of 32 GP's and avg. incremental length is 2756 mtr per GP. Soil strata classification and figures in meters compiled in the survey report are based on visual inspection and past experience of BSNL officers who have prepared this report. This technical sanction acknowledges the fact that actual classification and distances of soil strata will be known and operated upon only during actual execution of the project. Similarly, it is acknowledged that bill of materials submitted with the survey report may undergo changes as per actual situations arising at the places of installation and as per specifications of equipments available at the time of installation of the project. This sanction does not cover the optimization of OLT placement and splitter design.

 The following points further action are to be taken by BSNL before actual execution. The action taken in compliance to these points are to be reported to BBNL in writing as well as upload in Primavera.

### Observations on Chincholi Block:

- The latitude and longitude details of the OLT location, intermediate tapping points and splitter locations should be given for the entire block. At present the lat long details are provided only for the GP and its nearest FPOI.
- The latitude and longitude details of all the GPs and its FPOI should be given in degree-decimal format having six digits after decimal for proper accuracy as per the survey guide lines issued by BBNL.
- The loss declared for the existing cables in the data sheet should be verified and entered correctly as it will have effect on the link budget.
- Salgar Basanthpur GP: AS per L14 diagram, the incremental length is shown as 9 Km, but in the NIC map the existing cable is at 0.5 Km from the GP.
- For the following GPs the lat long of GPs showing at different location and it should be corrected
   Chimanchod GP
- For the following GPs the lat long of FPOIs showing at different location and it should be corrected

Karajkheda GP, Venkatapur GP
