



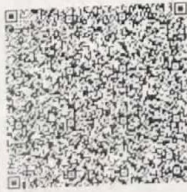

### BANK GUARANTEE

(hereinafter called the Principal) and head projects "Jio Digital Fibre Private Limited, 101, Saffron, Nr. Center Point, Panchwati 5 Rasta, Ambawadi, Ahmedabad-380006, Gujarat" (hereinafter called Contractor). We, IDFC FIRST Bank Limited having our registered office at KRM Tower, 7th Floor, No. 1, Harrington Road, Chetpet, Chennai - 600 031, Tamil Nadu, India and one of the branches at IDFC FIRST Bank Limited, SCO. 169-170, Ground Floor, Sector 8-C, Madhya Marg, Chandigarh - 160008 (hereinafter referred as "The Bank") hereby undertake to pay the principal an amount not exceeding Rs. 3,62,500/- (Rupees Three Lakh Sixty Two Thousand Five Hundred only) against any loss or damage caused to or suffered or would be suffered by the principal, by reasons of any breach of the terms or conditions contained in the said agreement.

2. We, IDFC FIRST Bank Limited, do hereby undertake to pay the amount due and payable under this guarantee without any demur, merely on a written demand from the principal stating that amount claimed is on account of making good and executed trench for laying of underground cable of proper filling and compaction, as to restore the land in the same condition as it was before digging the trench, debris/loose earth produced due to execution of trenching. However, our liability under this guarantee shall be restricted to Rs. 3,62,500/- (Rupees Three Lakh Sixty Two Thousand Five Hundred only). We undertake to pay the principal any money so demanded notwithstanding any dispute or disputes raised by the contractor(s) in any suit or proceeding pending before any court or tribunal relating there our liability under this present being absolute and unequivocal. The payment so made by us under this guarantee shall be a valid discharge of our liability for payment there under and the contractor(s) shall have no claim against us for making such payments.

We, IDFC FIRST Bank Limited, further agree that the guarantee hereincontained shall remain in full force and effect during the period that would be taken for the performance of said agreement and that it shall be continued to be enforceable till all the dues of the principal or by virtue of the said agreement have been fully paid and its claims satisfied or discharged or till the principal certify that the terms and conditions of the said agreement have been fully and properly carried out by said contractor and accordingly discharges this guarantee or till 06-05-2023, whichever is earlier, we shall be discharged from our liabilities under this guarantee thereafter.
