Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of 13.962 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above-mentioned proposal of the State Government the following information/clarifications are still required to be submitted:

- (i) Justification for locating 29 muck dumping sites on forest land measuring an area of 3.1715 ha when there are large stretches of NFL in the proposal.
- (ii) Detailed muck disposal plan with financial implications.
- (iii) DGPS map of project site with proper geo-coordinates to be submitted instead of Google Earth screenshot.
- (iv) DGPS map of CA site with proper geo-coordinates to be submitted.
- (v) Additional area of 4.0 ha for CA to be provided as the CA area has been found deficient for suitable vacant space to meet target plantation.
- (vi) Undertaking to pay Addl. NPV is not given.
- (vii) Recommendation from Nodal Officer is not given. { *Law it is possible?* }

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want of information.
