With reference to the letters on the subject cited above, I am to inform that General Manager, MCL, Subhadra Area has requested for issuance of allotment order(NOC) for Non Forest Govt. land and Degraded Revenue Forest land for the purpose of Compensatory Afforestation in favour of Subhadra OCP against diversion of 125.24 ha. of forest land within the project for mining purpose.
