Acacia trees with girth ranging from 0.20 mtr. to 0.40 mtr. The proposed forest area is Reserve forest and comes under eco class-I dense forest.

The proposal for diversion of 0.4928 Ha. of forest land in F.Sy.No. 215A1A of Arav village, Karwar taluk for building stone quarry and approach road to proposed stone quarry in Gopshitta Range may be considered for diversion of forest land as per the Forest Conservation Act,1980.
