The Applicant in Item A-3(i) to (vi) is different from the one authorized in Item A-3(xvii).

- 1. Please ensure that the Applicant is duly authorized to file this application.
- 2. In case of any difficulty in editing because of technical restrictions on FC web portal, you may choose to submit a fresh application (new proposal Number) with the correct name.

We have again changed the applicant name from Mr. Binay Prakash Pandey to Mr. Sunil Kumar Singh. The name change was carried out in online FC Portal under "My Profile" section. It clearly shows the details of the new applicant in whose name the authorization letter is uploaded.

## 2.L. Details of land identified for Compensatory Afforestation:

- (i) Whether non-forest or Revenue forest land is required to be provided by User Agency?
- (ii) Reason for not providing Non-Forest Land

No' option is selected in Item L(i) and the text 'Renewal of lease where compensatory afforestation had been stipulated and done in respect of the applied area at the time of grant/renewal of lease earlier. ' is given as the reasons for not proposing CA land.

- The statement 'Moreover, it is a time taking ......Becomes irrelevant' given in the document named 'Para-wise replies to the queries raised' uploaded in Additional
- Infom1ation Details brings ambiguity on the stand of User Agency on the issue of proposing the equivalent extent of CA land in instant proposal.
- 1. Please note, as informed earlier too, that there is no exemption from CA for the present proposal, as the CA provisions are equally applicable to all FC proposals. The instant project requires an equivalent non-forest land to be identified (now) and provided (only after Stage-I approval) for compensatory afforestation (CA) in accordance with Para 2.1 & 2.3 of the FC Guidelines and also the Government of Karnataka Order FEE 88 FLL 2016 dated 31-08-2016 (which mandates providing private Land either as forest enclosure or adjoining forest area in man-animal conflict zone). However, the Government of India decision on the above stand will be final.
- 2. Please specify clearly whether the User Agency is going to propose equivalent extent (i.e., 100.282 or 101 ha) of non-forest CA land eligible under G.O. dated 31-08-2016 as indicated above.
  - a) If yes, technical details of such land (as sought earlier) are required to be uploaded in PART-I of Stage-I proposal itself (and not after Stage-I approval). There is no exemption given by GOI under FC Guidelines on this issue.
  - b) If the User Agency takes a stand that no CA land is required in instant proposal, please upload a letter (on official letterhead) stating the exact reasons for taking such a plea w.r.t. CA land in Additional Information details, so
