
Sub:- Reply of Essential Details Sought in Forest Proposal No. FP/JK/OFC/144255/2021.

Sir,

As desired, the point wise information as asked for is submitted for favour of information and kind, perusal, please.

S.No.	Information Required	Reply
1	Clarification dated 24.03.2022 from DFO states that joint inspection has only been carried out up to Hynen from Bhandarkot, while UA has proposed diversion of 1.54 ha of forest land, which has been supported by UA in undertaking dated 14.03.2022. However, Site Inspection Report of DFO mentions proposed forest area to be diverted as 0.8177 ha from "Bhandarkot to Qaderna". If a component of the same project is left to be inspected, the same may be completed and project uploaded as one proposal for processing.	The joint inspection has been carried from Bhandarkot upto Hynen. An area of 0.8177Ha has been proposed for diversion for Underground and Aerial cable from Bhandarkot to Hynen. To this effect an Undertaking for change in Nomancature has been received from user agency. Moreover an area of 1.54 Ha of Forest land has been proposed by User Agency for diversion for Underground and Aerial cabling from Bhandarkot to Qaderna Village whereas 0.8177 Ha of Forest Land has been proposed to be diverted for Laying of OFC Cable from Bhandarkot to Hynen. Moreover the User Agency has also clarified it.
2	Component-wise break-up of the project does not mention area for aerial cabling and for underground laying of OFC separately.	Component wise breakup of the area for Aerial and Underground laying of OFC has been uploaded in additional documents.
3	Proposal on behalf of UA has been uploaded by "Jio Digital Fiber Private Limited". However, Certificate of Incorporation uploaded by UA states name of enterprise as "Summit Digitel Infrastructure Private Limited", which has been changed from "Reliance JioInfratel Private Limited". While Power of Attorney for local representative of UA is given by "Reliance JioInfocomm Limited" in favor of Shri Salman Lone. Registration Certificate for IP-1 has been issued in favor of "M/s Infotel Broadband Services Limited" by Department of Telecommunications, Ministry of Communication & IT, dated 23.06.2011. Fresh Certificates of Incorporation have been uploaded for the change of name from "Infotel Broadband Services Limited" to "Reliance JioInfocomm Limited" and "Jio Digital Fiber Private Limited". All these documents leave unfilled links in the chain and are cause of confusion as to the authority of person making application on behalf of UA.	Clarified by the User Agency and also uploaded in additional documents.
4	Forest Department may clarify the extent of the OFC to be laid along existing RoW, for this office to make a decision regarding applicability of General Approval.	The extent of OFC proposed to be laid along existing RoW right from Bhanadarkot to Hynen Village. The average forest area to be involved is 0.8177 Ha besides Non-forest Land is also involved in this project.
