- On conducting inspection of the proposed alignment, it is found that the land required by the User Agency is a forest land measuring **8.23 ha** of compartment No. 08/N, 13/N and 14/N (North Range, Ramnagar Forest Division).
- The proposed requirement of land is unavoidable and bares minimum forest area i.e. **8.23 ha**.
- The User Agency has not violated the provision of Forest (Conservation) Act, 1980.
- 1147 Nos. of Chir and broad leaved species of trees/poles/saplings are involved in the proposed alignment. Apart from this 3888 Nos. of medicinal bushes viz *Berberis aristata*, *Rubus ellipticus*, *Rosa masqita*, *Viburnum tinus* & *Gharna* etc are also involved
