Sub: Diversion of 32.49 Hectare of forest land (30.09 Ha for Mining lease and 2.40 Ha for approach road) in Ramanamalai Block Forest, Sandur North Range, Sandur Taluk, Ballari District (Ramdev Iron Ore Mine. M.L.No. 2563 Erstwhile C- category mine e-auctioned), in favour of M/s MSPL Limited, the preferred Bidder. (Proposal NO. FP/KA/MIN/50114/2020 (Form-A)) – Reg.

With reference to the above subject and as per Your good office letter vide ref (1) mentioned above, we would like to bring to your kind notice that we, MSPL Limited got transfer of FC Clearance for 30.09 Ha, co-terminus with the validity of lease granted under MMDR Act, 1957 vide ref (2) from erstwhile FC lease holder M/s. Kanhaiyalal Dudheria in respect of Mining lease No. 2563, Ramanadurga village, Sandur Taluk, Bellary District.

Our online proposal No. FP/KA/MIN/50114/2020 (Form-A) for Diversion of 32.49 Ha of forest land includes 30.09 Ha of Mining lease area and 2.40 Ha of Approach road area.

As we only got transfer of Mining lease area vide ref (2), we need the diversion of forest land for 2.40 Ha of Approach road to commence the Mining operations.


We have provided 15.30 Ha of CA Land for Approach road and Mining lease area at Amagaon village, Khanapura Taluk, Belagavi District in Sy No. 6/4, 6/5 and 6/6 and got the suitability certificate in Form-B from DCF, Belagavi. Out of 15.30 Ha of CA land area 2.40 Ha area is for Approach road for Ramdev Iron Ore Mine. The DLF area of the above CA Land has been identified and map has been submitted by DCF Belagavi to DCF Ballari.

The above 15.30 Ha of CA Land area has been transferred, Mutated and Handed over to Forest Department Belagavi. Copies enclosed for your ready reference.

In view of the above, we request you to process the proposal for Diversion of Forest land of 2.40 Ha Approach road by excluding 30.09 Ha of Mining Lease area.

Hence, please process the FC file for approach road of 2.40 Ha and forward for further approval.
