Dear Sir,

GAIL (India) Limited, a Maharatna Company, under the aegis of **Ministry of Petroleum & Natural Gas, Govt. of India**, is engaged in transportation and distribution of Natural gas to various Fertilizer, Power, Steel, Petrochemical Plants, Industrial Units and also facilitate Natural Gas in the form of CNG and PNG. Presently GAIL is having a huge pipeline network of more than 13000 Km across India. GAIL is contributing a major role in India's energy requirement & distribution through continual expansion of its pipeline network.

Further to inform that Petroleum and Natural Gas Regulatory Board (PNGRB), an autonomous body set up by Govt. of India has authorized GAIL (INDIA) Limited vide Letter No. Infra/NGPL/124/GAIL/ JHBDPL/01/18.dtd 29.01.2018 to Lay, Build and Operate approx. 2600 Km Natural Gas Pipeline Network (Jagadshur-Hadia-Bokaro-Dhamra natural Gas Pipelines (JHBDPL) and spur lines) in the state of UP, Bihar, Jharkhand, Odisha and West Bengal.

In line with Authorization granted , GAIL has proposed to lay a 12" dia, 112 Km long Natural Gas pipeline along with OFC originating from mainline (JHBDPL) in village Dandua, Block Raghunathpur, District Purulia (West Bengal) and terminating at Jamshedpur (Jharkhand). The length of pipeline passing through Purulia District is 80 km approx.

There is 80 Km pipeline length falling in Purulia District and a total 5.7786 Ha. of forest land required to be diverted for laying pipeline. Village-wise/ Block wise details of forest lands are attached herewith as Annexure-A

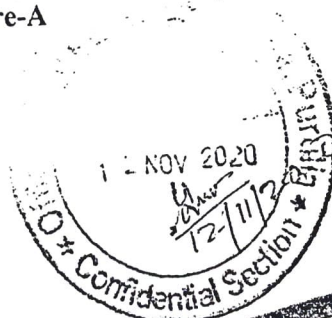
