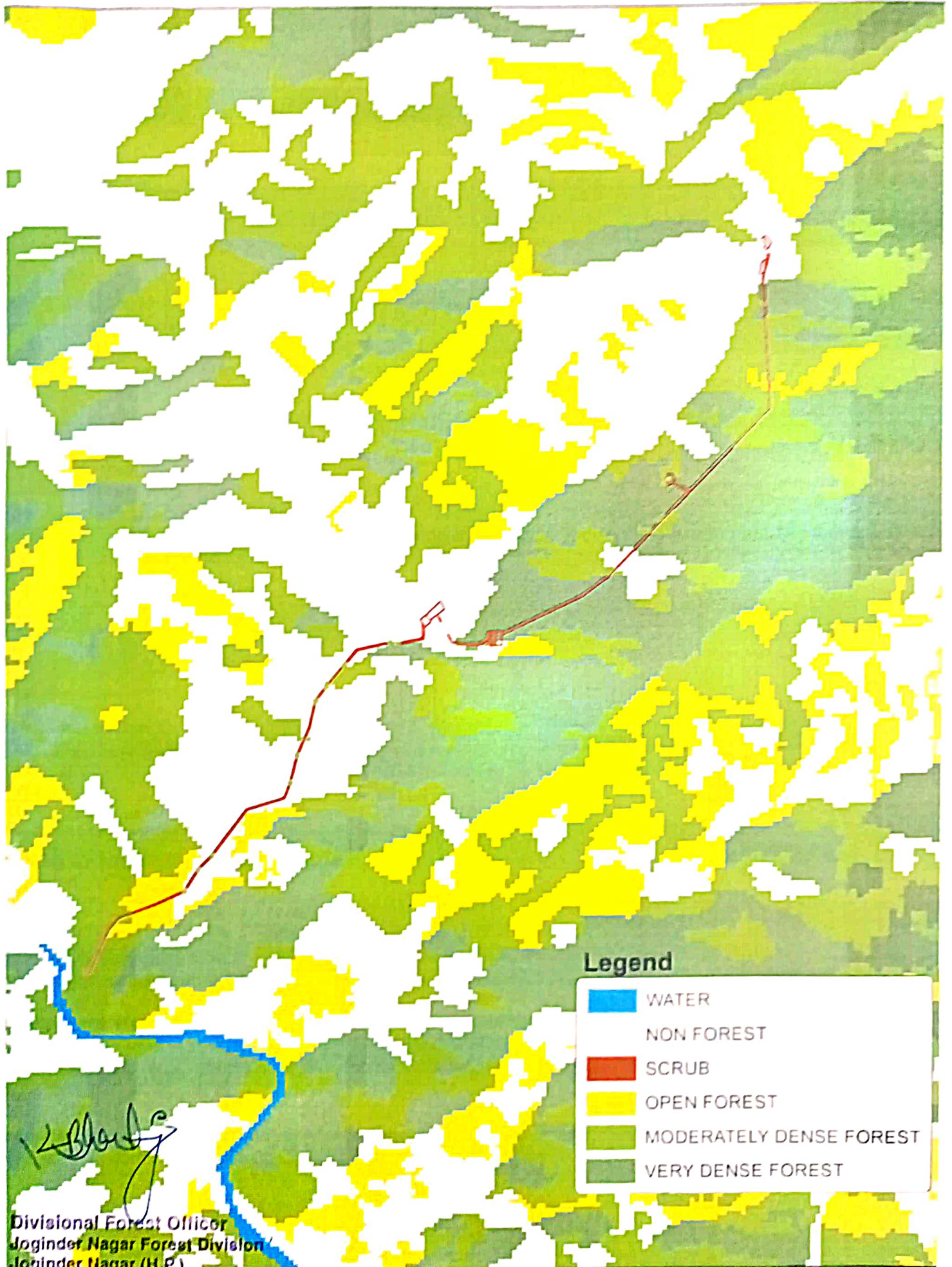

The User Agency sent reply to corresponding observation that 25% of the muck so generated will be used in filling behind retaining wall, rock pieces which are dress able will be used for construction of wire crates, retaining walls, breast wall, 20% of the collected pieces of rock from underground as well as open excavation will be transported to crusher site and crushed to various grades for use in lining of the HRT tunnel and other RCC structures where ever suitable and 10% of the muck will be used in soling work in roads i.e. approach road to power house, other components of the project & link roads near project area. The remaining 45% of muck will be disposed of at the dumping sites.
2.	Has the revised diverted area checked through DSS analysis.	The revised diverted area checked through DSS analysis and DSS analysis report enclosed herewith.
3.	Revised CA area is on steep slope. pl. check the slope.	The slope of the area checked and found that the slope of CA area is approximately 60 ° and the site is suitable for plantation.

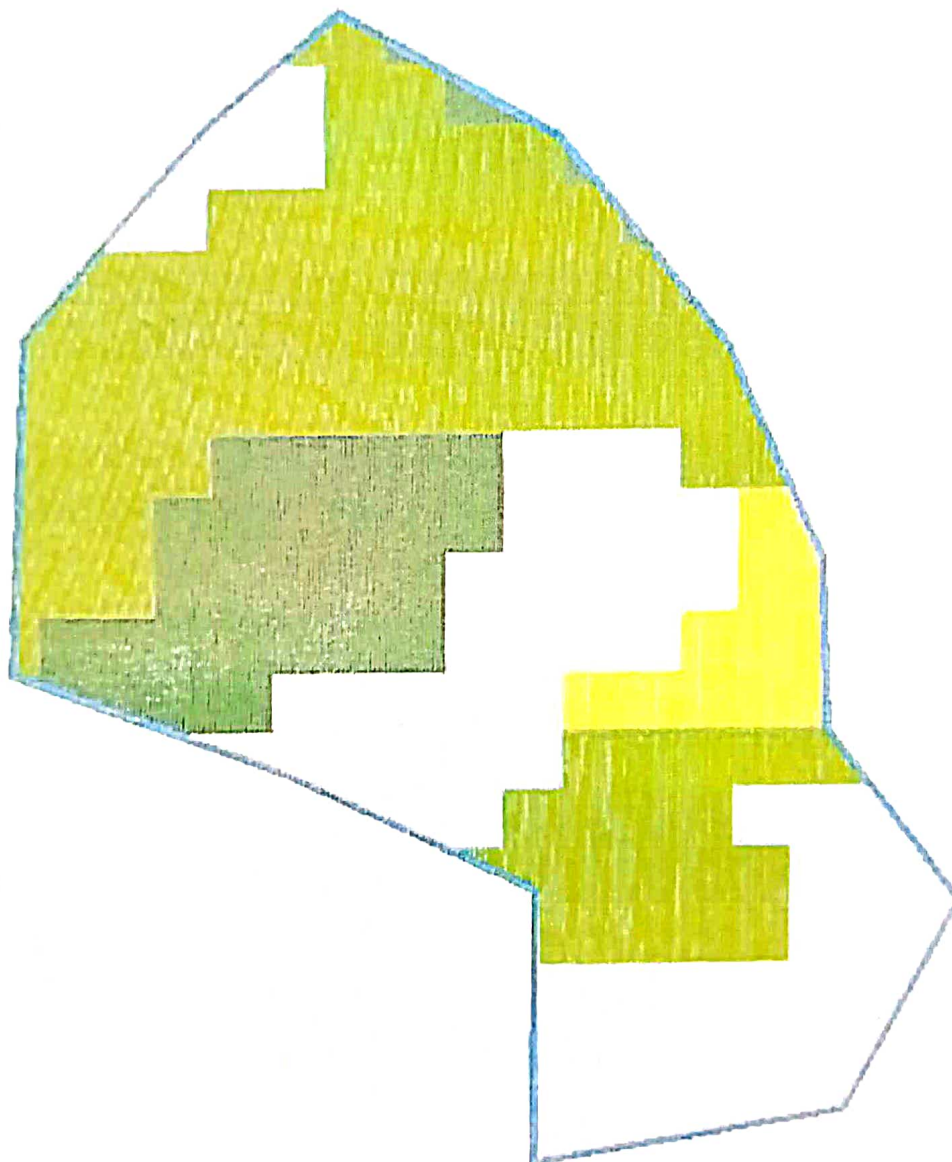
It is, therefore requested that the necessary Stage-II approval for the diversion of above land may kindly be obtained from competent authority please..

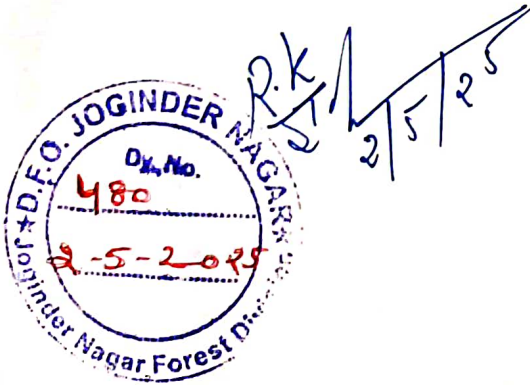
