1	As per GIS DSS analysis, following issues need rectification / clarification- a. Original Survey of India toposheet for proposed Forest land diversion and proposes compensatory afforestation has not been provided with the proposal. b. Key geo-coordinates have not been provided on geo-referenced map for proposed forest land for diversion. c. Google Overlay of kml file of proposed forest land shows existence of road within its boundary and some boundary wall like structure also.	a. Original Survey of India Toposheet for Forest land Proposed for Diversion and Proposed CA land is enclosed. b. Revised Digital Map is uploaded in Part-I. Hard copy is enclosed. c. We hereby undertake that existing road is prior to 1980. Documentary proof is enclosed.
2	It appears from Google Earth overlay that already a road along with other permanent structure exists within proposed forest land for diversion but it has not been mentioned in part-II of the proposal. The proposal needs a relook on account of violation of provisions of FCA 1980.	We hereby undertake that existing road is prior to 1980 and we have not carried out any additional work on required land proposed for diversion.
3	In the section D of part I of the proposal " justification of locating the Project in forest land and details of alternatives examined" existence of road within forest land and non examination of other alternative. it is mentioned that the proposal is for road widening whereas KML file shows entire road has been taken up. These two issues are totally divergent and misleading. The proposal needs to be reframed for details, violation existing at ground level.	The submitted proposal is for For Widening; Strengthen & Recarpeting of Road From Delhi Gate NH-79 Via Manpura/ Gopalnagar, Chittorgarh, Rajasthan state therefore the alignment is taken as per existing road keeping in the view that minimum trees will be felled. Already existing road not diverted earlier and existing road is prior to 1980 therefore no FCA violation is there.

6	Working plan prescription for the proposed forest land diversion at Sr. No. 5 in part II has not been mentioned.	Related to Forest Department.
7	i. Estimate for compensatory afforestation has not been provided in the proposal online ii. No. of plants to be planted per ha for CA scheme has not been submitted. iii. Detailed CA scheme has not been submitted with the hard copy of the proposal.	Related to Forest Department.
8	The issue of violation of FCA 1980 needs a relook and if the exists pre 1980, the same needs documentary proof.	We hereby undertake that existing road is prior to 1980. Documentary proof is enclosed.
