

**Report on Compliance to Statute(s), Circulars and directives issued by Govt. of India, MoEF.as applicable to the project.**

1. No. 11-168/2009-FC dt.14.02.2014- Submission of Mining Plans reg.

The User Agency has submitted the mining plan duly approved by IBM.

2. No.11-362/2012-FC dt. 01.02.2013- Submission of proposal to obtain approval for diversion of entire forest land located within the Mining Lease and grant of Environment Clearance to Mining project.

The lessee has obtained final approval under sec-2(ii) of FC Act, 1980 vide F.No. 8-17/1997-FC(pt) dated 11.12.2012, 09.07.2013 and 12.11.2014 of MoEF, Govt. of India over 1225.78 ha forest land within ML .

The environmental clearance has been accorded by MoEF, Govt. of India vide No. J-11015/418/2008-IA.II(M) dated 21.12.2012 for production of Iron ore from 5.65 MTPA to 12.0 MTPA.

3. No.8-25/2000-FC dt.12.07.2012- Guidelines (Para 4.7 (i)) for diversion of forest land for non-forest purposes under the Forest (Conservation) Act, 1980.

The proposal for diversion of forest land over 73.20 ha located within the safety zone has been approved vide F.No. 8-17/1997-FC(pt) dated 12.11.2014 as per guidelines as mentioned in Para 4.7 (i) of F.C Act,1980.

4. No.11-73/2014-FC dt.13.05.2014 – Simplified procedure to obtain approval under the Forest (Conservation) Act, 1980 for diversion of forest land located in safety zone of existing mining.

The proposal for diversion of forest land over 73.20 ha located within the safety zone has been approved vide F.No. 8-17/1997-FC(pt) dated 12.11.2014 as per guidelines as mentioned in Para 4.7 (i) of F.C Act,1980.

169.72 ha of degraded forestland double the extent of forest land 84.86 ha excluding safety zone over 2.23 ha for CA has been identified & allotted in Karo RF under Barbil range for raising Compensatory afforestation

9. No. 11-306/2014-FC dt.07.10.2014 – Enumeration of trees available on the forest land proposed to be diverted for non-forest purpose –reg.

2957 Nos.of trees (Virgin-434 Nos. & broken up- 2523 Nos.) and 1150 Nos. of poles (Approx.) is to be felled. The probability of soil erosion is likely to increase following felling on the undulating topography of the applied area. It is mentioned that presence of tree growth in the broken up land up to the tune of 2523 is due to afforestation measures taken up by the User Agency.

10. F No. 8-78/1996-FC (Pt.) dtd 10.03.2015 –Diversion of non forest land recorded as forest ason/after 25.10.1980.
