Justification for Locating the Project in Forest Land

The Venkateshwara Lift Irrigation Scheme raising main pipe line is proposed in the Bandigani village forest land through Sy. No. 21. This raising main passes between the two hills and in the back drop of the lagoon of Bandigani village. This forest land of Sy. No. 21 which is feasible and economic for this project as compare to other alternative alignment, because this village area contains Banahatti reserve forest on the left and right side about 4km and 10km stretch length respectively and as well as this area is higher elevation. In this condition it is not technically feasible to operate the raising main pipe line in this area. Another reason is that pipe line design should be such that minimum bends and curves to be maintaining vertically and horizontally. And there is no other private space or non forest land is available in this surrounding area. So as mentioned above Sy. No. 21 land is very suitable and feasible for this economic construction of this project.

Justification

A detailed reconnaissance survey work has been conducted to locate raising main in the economic way. And also detailed to Topographical study has been made to trace out raising main alignment and related structures. Accordingly component wise detailed estimate for Head work including raising main and Canal networks are prepared.

After the detailed investigation it was found that Bandigani Village area contains Banahatti reserve forest on the Left and right side about 4.00 KM and 10.00 KM length respectively. There is no alternate route without touching this forest area, and also contains higher ground it is not technically feasible to take alignment in this portion. Finally we got the valley portion near Bandigani Village Survey No.21 it is technically feasible and economic.
