Preamble:

In the G.O. read at Sl. No. (1) above, the Government of Karnataka has accorded approval to take up the balance work of Kadur-Chikkamagalur-Sakaleshpur new railway line project on 50:50 cost sharing basis between Government of Karnataka and Ministry of Railways.

2. The Chikkamagalur – Sakaleshpur portion of Kadur – Chikkamagalur – Sakaleshpur New Railway Line was frozen by the Railway board vide letter dated 19-09-2007 read at sl. no. 2 and the works between Chikkamgalur – Sakaleshpur were not taken up. 10.00

3. In the letter read at Sl. No.(3) above, the Principal Secretary, IDD requested Railway Board to sanction the frozen portion i.e. the Chikkamagalur – Sakaleshpur section of the Kadur – Chikkamagalur – Sakaleshpur New Railway Line on 50:50 cost sharing basis and assured to provide the required land free of cost.

4. In the letter read at Sl. No. (4) above, the Railway Board de-freezed the works on Chikkamagalur – Sakaleshpur portion and authorized South Western Railways to take up the work of above said section.

5. In the letter read at Sl. No. (5) above, the Dy. Chief Engineer/ Constn./ West-1, SWR, Bangalore submitted the revised detailed estimate of Rs.657.80 crores for the Chikkamagalur – Sakaleshpur Section of the Kadur – Chikkamagalur – Sakaleshpur new railway line project for further action from Government of Karnataka. This proposal has been examined and hence the order.

GOVERNMENT ORDER NO: IDD 146 NSW 2013, BANGALORE DATED: 03.03.2014.

In the circumstances explained in the preamble, Government of Karnataka accords administrative approval to take up the work on the defrozen Chikkamagalur – Sakaleshpur section of the earlier approved Kadur – Chikkamagalur – Sakaleshpur New Railway Line project at a cost of Rs.657.80 crores on 50:50 cost sharing basis between Ministry of Railways and Government of Karnataka and to provide the required land free of cost to SWR. Government of Karnataka will bear the cost of land required for the Chikkamagalur – Sakaleshpur section of this railway line project.
