1.	The Justification submitted in response to Point No. 1 is not in consonance with the observations of the GoI. The detail of the explored alternatives has not been furnished adequately. The justification needs to be revised and submitted in greater detail, including particulars such as enumeration, area involved and other relevant specifics as specifically sought by GoI.	The <b>alternate-I</b> has been selected for the proposed project as most suitable & feasible as per requirement of the project and <b>alternate-II &amp; III</b> are rejected as not suitable and feasible as per requirement of educational institution. The revised Justification for alternate examined including particulars such as enumeration, area involved has been uploaded against additional information detail in online Part-I at serial No. .
2.	In response to observations at Point No. 5, 6, 7 and 9, it has been stated that the requisite information /documents have been uploaded on the portal. However, the details of the uploaded documents such as Sr. No., Column No. etc. have not been mentioned. The same may be clearly indicated.	In response to EDS at Sr. No. 5 of GoI, the Eco Sensitive Zone Certificate clearly mentioning the distance of the proposed site from WLS has been uploaded against the additional information detail at <b>Sr. No. 15</b> in online Part-I.
