APPLICATION FOR GRANT OF PRIOR APPROVAL FOR 1st RENEWAL OF DIVERTED 0.90 Ha. OF FOREST LAND IN RAMAVARAM R.F., RAMAVARAM RANGE, KOTHAGUDEM FOREST DIVISION OF KHAMMAM DISTRICT BEING USED FOR SUBMERSIBLE PUMPS AT PADMAVATHI KHANI COAL MINE OF SCCL, KOTHAGUDEM AREA.

MoEF, GoI vide its letter No.8-277/85-FC, dated. 18.08.2008 granted Diversion of Forest land to an extent of 0.90 Ha. in Ramavaram R.F., Ramavaram Range Compt. Nos. 4&7 in Kothagudem Forest Division under Sec.2 of Forest Conservation Act 1980 for a period of 10 years (copy enclosed).

2. Project details:

 Short narrative of the proposal and project/scheme for which the forest land is required.

The present proposal is for prior approval for 1st renewal of 0.90 Ha. of Diverted Forest Land being used for pumping house, approach road, transmission line and pipe lines.

The submersible pumps installed in the pump house are being used to pump out the water from water logged area in No.1 seam of abandoned 5B incline for extraction of Coal from under lying Coal Horizons namely Top Seam and King Seam of padmavathi Khani Under Ground Mine.

Padmavathi Khani in Ramavaram RF is one of the ongoing underground coal mines of SCCL at Kothagudem area presently producing 5.00 Lakh Tones of Coal per Annum. The installed Submersible pumps are over the water logged area of No.1 seam on surface (South side) where extraction of

Coal was already completed by No.5B Incline. For the extraction of coal from the underlying Top & King Seams of Padmavathi Khani, the goaf / void area of above No.1 seam of 5B Incline shall have to keep dry to comply with safety requirements as per Coal Mines Regulation of 1957.

The SCCL is having valid Mining lease for 1174.18 Ha. in Ramavaram RF for extraction of coal vide GOI(MOEF) letter No.8-277/85-FC dt.17.02.2009 for 20 years .The area of Padmavathi Khani & 5B incline are falling with in the sanctioned Mining Lease.

About 11.0 Million Tones of Coal deposits existing in Top Seam and King Seam of Padmavathi Khani can be extracted after de-watering No.1 Seam of 5 B Incline, which is a Coal conservation measure and optimum exploitation of non renewable fuel source. As already explained that dewatering is must to extract coal from Top & King seams, therefore constant bailing out of water from No.1 Seam of No.5B Incline is essential with already installed Submersible Pumps.

There will not be any additional mining /surface activity. The present activity like running & maintaining 2 pumps at Two spots and to let out the water or to use for various purposes will continue till the extraction of 11 million tones of coal from top & King seam i.e.20 years.

Therefore, the present application is submitted for 0.90Ha for grant of 1st Renewal for already diverted Forest land for further period of 20 years.
