In compliance of the Ministry of Environment and Forests (MoEF), Government of India's Letter No. 11-9/98-FC (pt.) dated 3<sup>rd</sup> August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5<sup>th</sup> February 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that 0.90.1 hectares of forest land proposed to be diverted in favour of TANTRANSOCO, Virudhunagar to carry out erection work of 765 KV D/C Transmission line from Virudhunagar to Coimbatore Reach I and passing over the Uthappanaickanur Village in Usilampatti Taluk, Madurai District.

It is further certified that :

- (i) The complete process for identification and settlement of rights under the FRA has been carried out for an extent of 0.90.1 hectares in Survey No.118 of Forest area proposed for diversion.
- (ii) Certified that there are no Scheduled Tribes and Other Traditional Forest Dwellers in Uthappanaickanur R.F.of Madurai District and consequently no claims have been received under this Act with respect to the area proposed for erection work of Transmission Line over this area.
- (iii) Certified that there are no Primitive Tribal Groups (PTG) and Pre-Agricultural Communities (PAC) in the Uthappanaickanur R.F, in Usilampatti Taluk, Madurai District. So, the recognized rights of PTG and PAC are not affected.


