- Work order amount under the tender as per approved rates will be Rs. 289,82,70,126/- (Rupees Two Hundred Eighty Nine Crores, Eighty Two Lakhs, Seventy Thousand and One Hundred Twenty Six only) as per details shown in schedule (BOQ).
- Increase in BOQ quantity up to 10% in items, whose rates are higher by more than 10% of Departmental rates, will be paid at the quoted rates. But if the increase in quantity of these items exceeds beyond 10% of BOQ quantity, then the increase in quantity beyond 10% of BOQ quantity will be paid as per Departmental rates. If the unit of BOQ quantity is in number then increase in quantity by 10% will be rounded to nearest whole number i.e. below 0.5 will be considered zero and 0.5 and above will be considered one.
