CCL's role be truly assessed by its contribution towards growth of new coal resources. The opening of new mines Jharkhand a significant change in these regions by creating new opportunities of industrialization, employment, and development of the Jharkhand.</p> <p>The proposed Magadh OCP is located in the northern fringe of the N.K. coalfield and lies in the Chatra and Latehar District of Jharkhand.</p> <p>This project shall act as a major source of direct and indirect employment, which will in turn help in uplifting the socio-economic status of villagers living in the core and buffer zone. Further, several community development activities to be carried out as a part of CSR and other heads. This project will help in developing the supporting infrastructure of nearby villages like roads, railway line, power transmission line, water supply etc. The Magadh East OCP is approachable by 12 Km long fare weather Kutcha road from Tandwa village which is connected to Khalari via Piparwar by a 20 Km long fare weather road in the south and to Hazaribagh by a 50 Km long Metalled road via Barkagaon. Another metalled road connects Tandwa village with Hazaribagh (80 Km) via Semaria. A fair weather kutcha road connecting Tandwa village with Balumath also runs close to this OCP, which in turn is connected to Khalari via Tori and Bijupara. The nearest railway station is the Ray, which is at a distance of about 35 Km from the block, on Barkakana Dehri-on-Sone loop line of the Eastern Railway.
