Respected Sir,

The Agricultural Produce Market Committee (APMC) Yellapur has been established as per Sec 3 of The Karnataka Agriculture Produce Marketing (Regulation and Development) Act 1966 and same has been declared as marketing area as per Sec 4 of the sais Act. The Agricultural Marketing System of the country is Characterized by various Short comings like heavy sales at Village level immediately after the harvest, Absence of On-Farm Grading of produce, Poor packing, Insufficient Marketing Infrastructure, Long Marketing Channels, Various Mal Practices, Low Marketable Surplus etc. The Govt has recognized the Importance of efficient Marketing of Agricultural Produce for overall Development of the sector has taken various Initiatives from Time to Time to overcome these Problems & Strengthen and Upgrade Agricultural Marketing System. Regulation has been introduced to overcome the problems faced in Traditional Marketing System by ensuring mechanism for proper sale of Produce, Weighment, grading & standardization, Market Information, Market Charges in propotion to the Service Provided, Prompt Payment without any unauthorized deduction.

The Agricultural Produce Market Committee (APMC) Yard Yellapur is having 15 acres of land in Sy.No.68A1A1A1 of Yellapur Village and has already built up main Market Yard and thereby all trade activities. 20 to 25 thousands farmers are in Yellapur Taluk growing the areca and other Agricultural Commodities and. more than 1.0 lack quintals of Areca are being sold per year in APMC Yard along with other agricultural commodities. Two major societies like TSS & TMS and 19 Commission Agents, 164 licensed Traders, Retailore 79, Importer 95, Exporter 97, Processors 07, Weighman 02, Hamali 46, Stockist 25 and Crushers 01 Totally Licence Holders are 535 were running their trading areca & other Agricultural Commodities in APMC Market Yard, Further most of the Co-Operative Societies and Banks are financing to farmers for agricultural activities in APMC Yard Yellapur. The APMC Yellapur has constructed the buildings for running the farmers growing agricultural product and trade business of agricultural products. The APMC Yellapur has developed APMC Yard by constructing the godowns, E- Tender Hall and provided space for farmers growing agriculture commodities, grading, Packing, etc. Due to non availability of land the APMC Yellapur is not in a position to

accommodate some traders in APMC Yard. Therefore some of the traders are running their business out side the APMC Yard. Hence it is necessary to avail some more area to bring the traders running their business out side the APMC Yard in to APMC Yard. The APMC Market Yard in Yellapur is just away from Yellapur town and adjacent to Yellapur -Sirsi Road. As the production of agricultural produce is increased and the agriculturists of Ankola, Joida and Mundagod Talukas are bringing their area crops to APMC Yard, Yellapur as there is no area market in the said talukas. Further the construction of godown for stocking the farmers growing area and other agricultural produce is very much needed for the benefits of agriculturists. It is also necessary to provide space for licensed traders to run their business in market Yard. For development of Market Yard minimum 2.0 hectares of land is urgently required to APMC, Yellapur.

The APMC Yellapur has searched for private lands or revenue lands but there is no any private or revenue lands are available, and even published the requirement of lands in news papers as per publication No. 443/2019-2020 dtd 29-06-2019 in Vijayavani and Karavali Munjavu daily news papers. But no body have come forward to sell the private lands. Further The APMC Yard Yellapur is surrounded by Forest area and there is no any private land or revenue land is adjacent to APMC Yard, Yellapur. The revenue authorities like have after inquiry have stated that there is no any revenue land is available and D.C.Karwar has given a certificate to that effect.. The Forest Sy.No. 68A1A1A1A1A1 OF Yellapur Village is just adjacent to existing market Yard of APMC, Yellapur. Further as per Sec 6 of The Karnataka Agriculture Produce Marketing (Regulation and Development) Act 1966 one market Yard is to be established. Therefore it is just necessary to extend the Market Yard in APMC Yellapur in the interest of publics at large. For extension of Market Yard minimum 2.0 hectares of land is required to APMC Yellapur.

Hence You are hereby requested to make recommendation for the proposal of APMC, Yellapur for Diversion of 2.00 hectare of forest land in Forest Sy.No. 68A1A1A1A1 OF Yellapur Village, Yellapur Taluka, Uttara Kannada District For Extension of Agricultural Produce Market Committee (APMC) Yard Yellapur in favour of Secretary, APMC Market Yard, Yellapur under proposal No. FP/KA/Others/29876/2017 to enable the APMC, Yellapur to extend the Market Yard area for the benefits of Agriculturists at large.
