2. The expenditure against the above work shall not exceed administratively approved estimated cost and funds sanctioned for the work. In case revised approval of estimate is required, the same will be obtained well in time.
3. No change in specifications and scope of work shall be made without specific approval of competent authority.




4. The constructional and structural designs and drawings shall be approved by the concerned Superintending Engineer before taking the work in hand.
5. The cost of this work is restricted to **Rs. 83,22,004/- (Rs. Eighty Three Lacs Twenty Two Thousand Four Only)** for this complete scope of work as per NIT.
6. The time limit is 6 (Six) months and it should be ensured to get the work be completed within the prescribed time limit.
7. The specifications/ makes of all the items to be supplied and fixed will be as per specifications/ makes mentioned in the NIT.
8. The 3<sup>rd</sup> party inspection will be adopted by Engineer-in-Charge. The 3<sup>rd</sup> party would inspect the work during its execution to ensure the construction of work as per specification/agreement. The inspection and sample testing charges will be borne by the Department.
9. The specifications/ makes of any item, for which, specifications/ makes have not been mentioned in the NIT and then the same will be finalized by the Engineer-in-Charge.
10. Labour cess @ 1% shall be deducted from the bills of the contractor/agency by Executive Engineer as covered under contract labour Act and will be deposited with Secretary, Haryana Building and other construction worker Welfare Board through demand draft payable at Chandigarh.
11. Performance security of Rs. 2,49,660/- i.e. 3% of contract price is required for the work to be kept as surety which will be refunded after the expiry of defect liability period, so you are requested to deposit amount of Rs. 2,49,660/- before undertaking the work.
12. All other terms and condition as per approved DNIT.






