This is with reference to your office letter (3) cited, on subject matter, wherein it was requested to issue the separate NoC from Km. 491.380 to Km. 493.380 in Sy. No.38 at Bandahalli village and Sy. No. 262 at Aruru village, as the stretch belongs to the Forest Department.

Based on the request made by your office, the Competent Authority RO, NHAl, Bangalore vide letter (2) cited, had already accorded approval for laying water pipelines along the highway from Km.489.475 to Km 497.200 & Km 544.460 to Km.545.170 and 3 Nos. of road crossing the highway at (1) Km. 496.000 (2) 543.720 & (3) Km. 545.160, which includes Forest stretch from Km. 491.380 to Km. 493.380.

Further, it is to inform that, Ministry of Environment & Forests, Regional Office (southern zone), Bangalore vide letter at reference (1) cited, had conveyed approval (Stage-II) for diversion of 14.20 Ha. of forest land in Kolar Forest Division for widening and strengthening of NH-7 in favour of NHAI.
