I, am directed to invite your attention to the reference 2nd cited, wherein, a statutory proposal with necessary enclosures in duplicate, submitted by Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad for diversion of 2929.83 Ha of forest land for Dr. B.R. Ambedkar Pranahitha Chevella Sujala Sruvanthi Project under Forest (Conservation) Act, 1980, was forwarded for according necessary approval.

- I, am to inform that the Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad vide his letter 4th cited, has submitted revised proposal for diversion of 1081.0149 ha of forest land in erstwhile forest Divisions viz., Kagaznagar, Bellampally and Mancherial for construction of Barrage at Tumidihetti village and main canal for Dr. B.R. Abmedkar Pranahitha Project in favour of Chief Engineer (Projects), Adilabad, due to some technical reasons and re-engineering. I, am to further inform you that out of the total area proposed for diversion of 1081.0149 Ha, an area of 54.9989 Ha in Kagaznagar division is falling in the Tiger Corridor that connects Kawal Tiger Reserve with Tadoba & Indravathi Tiger Reserves. A separate proforma proposal will be submitted to Standing Committee of National Board for Wildlife, New Delhi for their approval, after receipt of the same from Principal Chief Conservator of Forests (WL) & Chief Wildlife Warden, Telangana State, Hyderabad.
- 5. I, therefore, request you to obtain and communicate the approval of Government of India, Ministry of Environment, Forests & Climate Change, for the proposal for diversion of additional forest land in the reference 6th cited, under Section-2 of Forest (Conservation) Act, 1980, at the earliest.
