Sir,

With reference to the subject cited above, I am directed to say that the Bodoland Territorial Council is pleased to approve an additional 12.198 hectares of Govt. land covered under Dag No.226 of Sishubari village, Chirang mouza. This land is allocated for compensatory afforestation purposes as required for the expansion of Rupsi Airport.

This newly allocated area is in addition to the previously approved area of 31.66 hectares, totaling 43.858 hectares of Non-forest land in Chirang District for compensatory afforestation in order to compensate for the forest land to be diverted during the implementation of the proposed acquisition of land for improvement and up-gradation of Kokrajhar to Rupshi Airport road under package-I under Asom Mala Project in Kokrajhar District. The land so acquired shall be transferred to the ownership of the Forest Department, Govt. of Assam, for carrying out the necessary compensatory afforestation as approved by LR & DM Department, BTC, Kokrajhar in its File No.BTC/LR-812/2024 (Notesheet Page No.4).
