5. Technical details :-


Technical details of compensatory afforestation scheme are as follows:-

(a) General Details:- An area of 42.00 hac. will be taken up for planting under compensatory afforestation scheme in UPF-30 in identified land area. The area will be protected by Barbed wire fencing and conifer and broad leaves will be planted. 1100 plants will be planted per hectare.

- (b) Spacement :- 2.5 mtrs x 2.5 mtr.
- (c) Species :- Coniferous and other broad leave species.
- (d) Plantation Method :- Nursery grown two and half years old conifer plants and one year old broad leaves plants (in Polythene bags as well as naked root) will be planted in 30x30x30 cm and 45x45x45 cm pits in the selected area. Bush cutting will be done in the infested area. The plantation will be maintained for subsequent 10 years in which beating up of failures will be done. The plantation will be rainfed.
- (e) Soil Moisture Conservation Works:- Contour trenching will be done over the entire area to conserve the available moisture during rainy season so that moisture regime in the area is improved. Minor soil conservation works like trench works, check walls and check dams be done where ever required.
- (f) Protection (fencing, Watchman, people's participation etc.) :- Area will be protected from grazing by erecting barbed wire fencing at all vulnerable places around the plantation. Further watch and ward as also fire protection will be ensured through regular department staff.
- (g) Proposed Monitoring Mechanism:- The plantation will be monitored as per existing monitoring mechanism in the forest department. The plantation will also be monitored by GoI representatives as per instructions.
- (h) Any other information :- Nil.

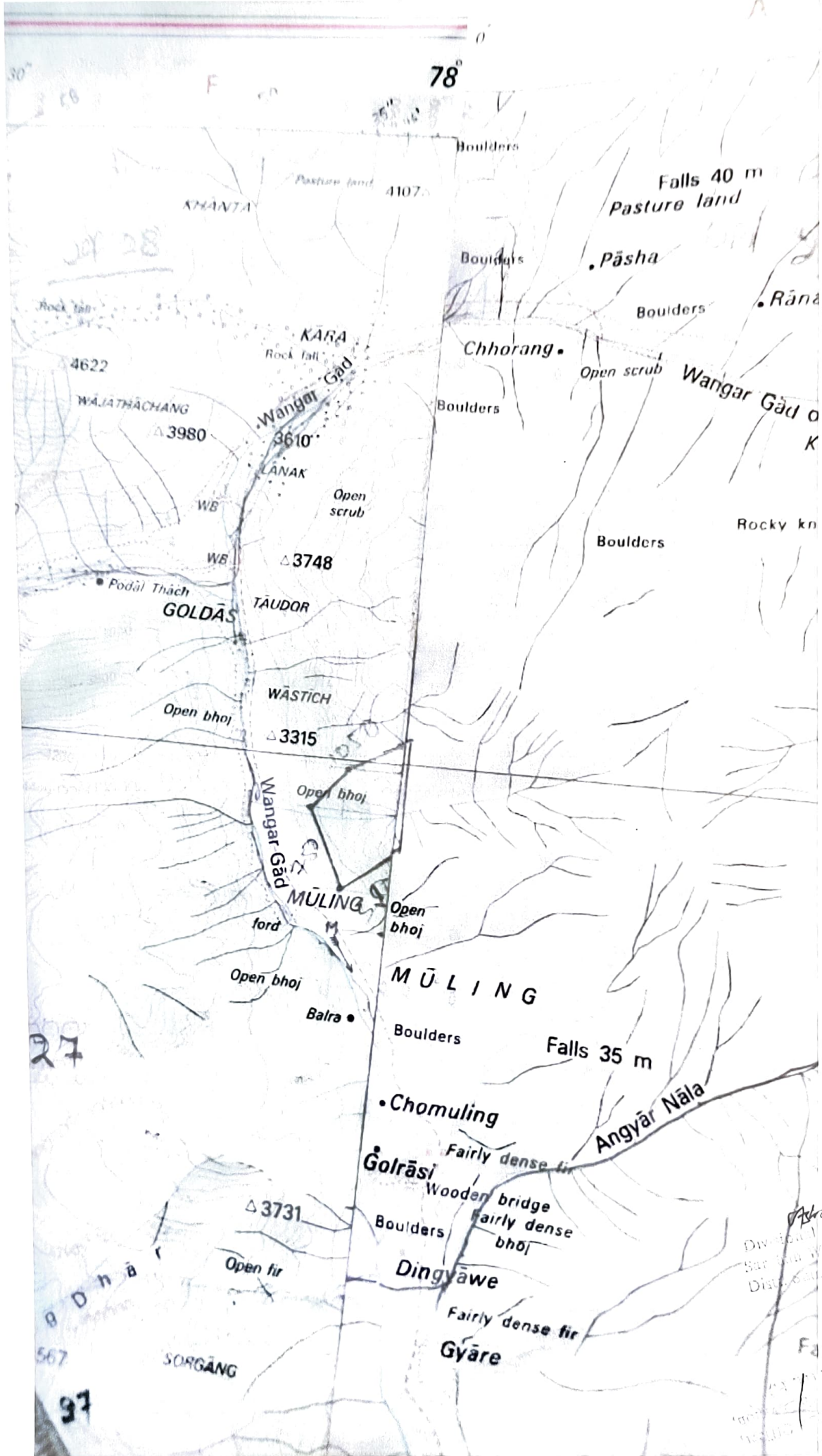

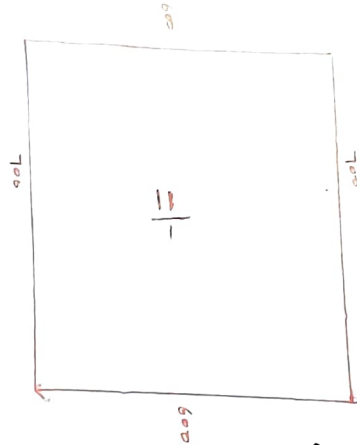
