Vide reference 1st cited, the SE, 400KV, TSTRANSCO has requested a "No Objection Letter" from GHMC for the road cutting in the stretch from Botanical Garden to Sudershan nagar, Cir-20,GHMC as the forest dept. requested TSTRANSCO a written consent from GHMC. TSTRANSCO also stated that the originally requested land was allocated to GHMC by Forest department and for considering any proposal of rediversion of forest land for non-forestry purpose under Forest (Conservation) Act. 1980. the TSTRANSCO has to make all applications with necessary documents along with written consent from GHMC.

In view of the above, it is to inform that the said road is under Comprehensive Road Maintenance Programme (CRMP) and the maintenance of the roads in Scrilingampally Zone was entrusted to CRMP agency "M/s.NCC Limited" for 5 years. As per the orders of the Government vide reference 2<sup>nd</sup> cited, Permission for the Road cutting on CRMP roads will be accorded by the CRMP agencies.

Further, GHMC has no objection for laying of TSTRANSCO Cable on the road from Botanical Garden to Sudershan nagar, Cir-20, GHMC subject to condition that proper road cutting permission is obtained as per rules.
