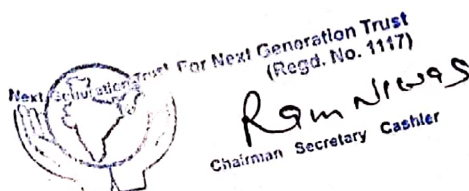

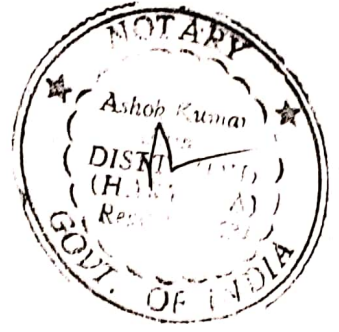

### LOCATION MAP


