13 Recommendation for the committee:


Construction of link road village Muhain km. 0/0 to 1/00 in District Bilaspur (HP) is under SCSP the involvement of forest land in this road is 0/0 to 1/00 km. This old path required to be windend to make it motorable. The status of land is un demarcated protected forest hence approval under FCA Act 1980 is required for this work. DPR amounting to Rs. Lac is prepared under SCSP by the department and is already submitted to S.E. office which is received back with some observation regarding land status. The case recommended for approval under FCA 1980. The damage restoration work under soil conservation / Bio-Engineer etc will cost Rs. 15.00 Lac


