1	In the additional document, provided the area of the road is mentioned as 0.0872 hect, which is not matching with area mentioned for road in component wise breakup of Part-I. Needful correction is this regards may be done.	Needful correction has been done
2	The area of the Transmission line in component wise breakup is mentioned as 0.3868 hect. Which is not matching with the area for Transmission Line mentioned in additional document. Needful correction is this regards may be done.	Needful correction has been done
3	In KML file , the right of way (ROW) of both Road and Transmission Line has been taken together as single component , whereas in componet wise braekup of Part-I and Layout Plan these all mentioned saprately. Therefore , it may be clarified whether , ROW of Transmission is overlapping the ROW of Road or not. Needful corrections in this regard may be done.	The land for road and Transmission has been acquired commonly upto the length of 200M with saprate ROW for each component i.e Road and Transmission Line. Road (ROW 4.36M) Transmission Line (ROW 7M). Road Length $200 \times 4.36m = 0.872$ Hect. T/Line Length $200 \times 7m = 0.1400$ T/Line Length $44.85 \times 7m = 0.0314$ T/Line Length $280.20 \times 7m = 0.1962$ Total T/Line Area = 0.3676 Hect. Needful correction has been done in KML and Layout Plan
4	Consent Letter was issued on 10-08-2015 and letter for bifurcation of proposal into two was issued on 27-11-2018. Therefore a fresh letter of consent is required before further processing of the proposal.	There is not any kind of provision to issue the fresh consent letter as informed by the Nodal agency for small hydro projects upto 5 MW in the state of Hmachal Pradesh HIMURJA. I am directed to inform that after considering your application for the Self Identified project, the State Government has consented to give you the exclusive right for preparation of DPR for subsequent implementation of SHP in H.P. The details of the project for which consent has been granted is as below:-

1. FR FINALISATION

The IPP shall submit a comprehensive Feasibility Report (FR) to Himurja prepared by a reputed consultant within six months of issuance of this letter along with the credential of the consultant. Feasibility Report (FR) shall be based on actual Survey & Investigation containing site detail, hydrological data, location of project components, power studies for capacity determination, land requirements, layout plan, single line diagram, E & M equipment specifications and cost analysis etc. Extension of three (3) months subject to deposition of extension fee @ Rs 10,000/- per MW per month is allowable. If the IPP fails to submit Feasibility Report within extended period project is liable to be cancelled.

2. IPP shall have to deposit security, processing fee, upfront premium based on the allotted capacity within two months from the date of issuance of this consent.

2.1. SECURITY (REFUNDABLE)

The Security charges (refundable) in the shape of Demand draft is to be furnished in favour of "DIRECTOR HIMURJA" payable at Shimla @ Rs. 50,000/- per MW. If the requisite documents such as PFR, Upfront premium and post allotment processing fee etc. as prescribed in the consent letter are not deposited in time, the project shall be cancelled and this amount will be forfeited. This amount will also be used as performance guarantee for different milestones and adjusted against extension charges that may have become due and were not paid in case of cancellation of project at any stage. (EMD deposited at the time of apply will be adjusted against Security)

The above security shall be refundable to IPP after signing of IA.

This is in continuation to consent issued on 10.08.2015 in respect of Banuala Baroond (5.00MW) HEP and request received from you vide letter no-nil dated 06.07.2018 for bifurcation of allotted project Banuala Baroond in two stages within allotted elevations. The State Government has approved bifurcation of project into two projects within allotted elevations of Banuala Baroond as per details given under:

The approval is subject to completion of codal formalities as per Hydro Power Policy 2006 and instruction/ amendments issued their under from time to time and following conditions:-

1. IPP has to deposit Upfront premium, Security charges and processing fee as fresh applicable as per prevailing Hydro Power Policy.
2. The above approval is further subject to the condition that the riparian distance of 50 mtrs elevation wise or 250 mtr horizontal distance is to be maintained between two projects to allow visible flow of water in the stream / nalla, failing which the allotment is liable to be cancelled for violation of the same.
3. IPP has to obtain the applicable NOCs as per policy provisions.

It is further stated that the exemption of extension fee for the delay in approval of change in elevations is subject to approval of Government.

Himurja/SHP/Banuala Baroond(298)/2015-85 dated 23.08.2019, vide which Feasibility Report in respect of Banuala Baroond (2.00MW) & Banuala Baroond-I (0.80MW) SHEPs in District Chamba has been submitted to Himurja. After examining the Feasibility Repbrt, the parameters are frozen as under:

It is further stated that the approval of the Feasibility Report (FR) of Banuala Baroond & Banuala Baroond-I SHEP in District Chamba shall be subject to the following conditions:-

1. There shall be no change in the elevations from the elevation freezes in the FR.
2. Discharge data has to be observed for optimization of capacity in the DPR, if it varies from the figure of Feasibility Report, Technical Concurrence is required to be obtained from DOE.
3. Evacuation land for transmission has been included in the Land requirement.
4. As per laid down guidelines riparian distance of 50 mtrs elevation wise or 250m horizontal distance is to be maintained between upstream and downstream projects to allow visible flow of water in the stream/Nalla while carrying out detailed survey/studies, but it is not demonstrated in the FR. The same should be followed strictly, failing which the allotment is liable to be cancelled for violation of the same.
5. Elevations of each component must be marked in the Contour plan and should also be included in the salient feature after carrying proper survey. Copy of which is also to be forwarded to Himurja.

Therefore, you may go ahead for obtaining various clearances/NOCs on the basis of parameters frozen herein above.

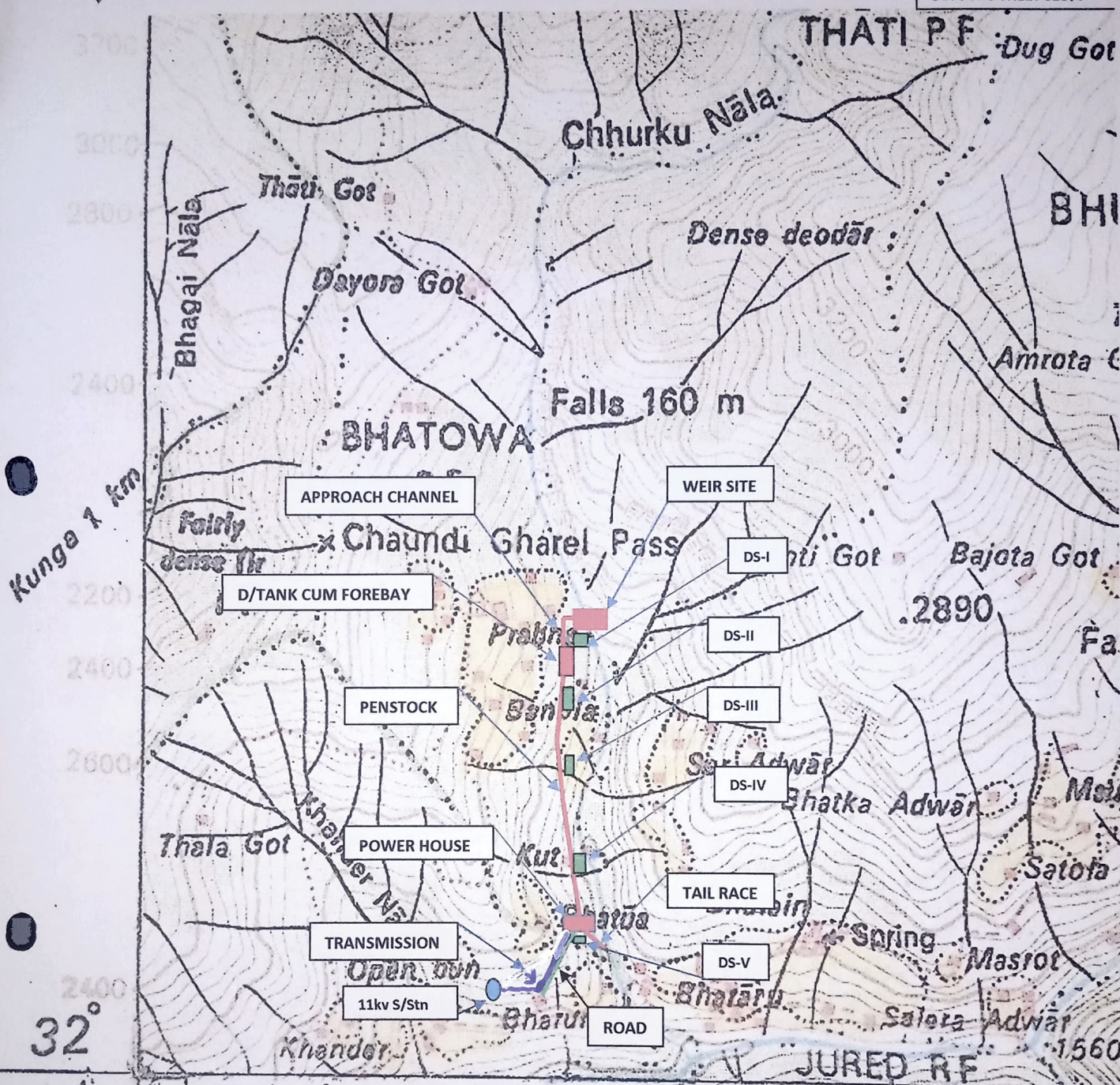
