

The total length of the project at which structures will be constructed is 15.586 km. Structure being improved under the project are ROB, Vehicular Underpass, Flyover, Major Bridge etc. The proposed widening shall be accommodated within existing RoW.

2. At present, the traffic congestion on existing highway is increasing day by day. The proposed widening and improvement shall reduce traffic congestion and result in time savings. 




