- Industry will not start its operation, unless CTO is obtained under water (Prevention and control of 4. Pollution) Act, 1974 and Air (Prevention and control of Pollution)Act, 1981 from the Board.
- It is mandatory to submit Air and Water consent Application, complete in all respect, four months 5. before start of operation, to the U.P. Pollution Control Board.
- Legal action under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and 6. Control of Pollution) Act, 1981 may be initiated against the industry With out any prior information, in case of non compliance of above conditions.

1. This Consent to Establish is granted for M/S Bharat Petroleum Corporation Ltd, Khasra No.

1378Sa, Jalesar Bahar Chungi, Tehsil-Jalesar, District-Etah.

2. This Noc is valid for Production of Retail-Outlet Storage Capacity-M.S.-15KL, & HSD-20 KL.

3. The proposed retail outlets should be installed in such a way that the surrounding ambient air quality is not affected.

4. Septic tanks should be set up to treat domestic effluents generated from the proposed retail outlets. 5. Plantation of maximum number of trees should be done in the premises of the proposed retail outlet.

6. The proposed retail outlet should ensure compliance with the conditions stated in the No Objection Certificate received from the fire department and an on-side emergency plan should be prepared to prevent any accident.

7. Compliance with Hazard's West Rules should be ensured by the proposed retail outlets.

8. A system of rain water harvesting should be established through the proposed retail outlets.

9. Water / air consent should be obtained by the proposed retail outlet before operation.

10. Vapor recovery systems should be installed by the proposed retail outlets for recovery of Vapor generated from the storage of MS and HSD.

11. In any case, proper arrangements should be made to prevent MS and HSD from spreading in the open by the proposed retail outlets.

12. Verification of the provisions of Plastic Waste Management Rules, 2016 should be ensured in letter and spirit.

13. Verification of provisions of Solid Waste Management Rules, 2016 should be ensured in letter and spirit.

14. Land use certificate issued from the competent authority level by the retail outlet should be sent to the office within three.

15. Diesel powered DG sets should not be set up if power supply is interrupted by retail outlets. Arrangement of DG sets operated by inverter, solar panel or LPG should be established only.
