4. Type of the CA land

The proposed Compensatory Afforestation area identified in non-forest land in two bits are Red soil mixed and suitable for raising of AR(SMM) plantation @ 1000 seedlings per hectare with the Forest species with tall seedlings of 1.5 mtr to 3mtr height by providing provision for watering. Soil Moisture Conservation (SMC) works can also be taken up.

The Compensatory Afforestation scheme has been prepared for the entire area of 12.75 ha of non-forest land identified.

Tall plants of size 8"x12" are proposed for planting in 0.45 mt cube pits to facilitate quick establishment and growth. For loosening the top soil and to facilitate water absorption and good growth ploughing is preferred.

2564 Rmt Chain-link fencing [Bit1-572 Rmt and Bit2-1992 Rmt] is proposed around the Compensatory Afforestation site (except towards Reserve Forest side) in two bits for avoiding encroachment and biotic interference etc.,

75 Nos Boundary Pillars are proposed to construct around the Compensatory Afforestation land in two bits.

Soil & Moisture Conservation (SMC) works are proposed to take up in the above CA area identified such as RFDs, PTs/MPTs, Check dams & CCTs etc.

The Compensatory Afforestation area should be raised under Semi Mechanical Method and to be maintained upto 10 years to ensure good results.


