AGREEMENT

- 1 Executive Engineer, I&PH Division, Palampur, Tehsil Palampur District Kangra Himachal Pradesh for and on behalf of I&PH Department as authorized by the department by the Principal Secretary (I&PH) to the Govt. of Himachal Pradesh vide Notification No. PBW (PH) F(1)-2/01 dated 20.1.2004 herein after called the first party.

BETWEEN

M/S Parshanti Hydro Energies Pvt. Ltd. Sai Sankalp Near PNB, Bagher Road, Panchrukhi Tehsil Palampur Distt. Kangra (H.P) 176209

TERMS AND CONDITIONS

The NOC is being issued with the condition that before starting the work of project at site, the firm shall lay MSERW Pipe from upstream of Head weir to the intake point of existing head works of WSS Rakh Kaloond, suitable to carry 15.55 lacs litres per day for which design shall be got approved from this office. The final NOC shall be issued after the work is executed at site and tested to the satisfaction of the department.

- 2 That for any modification to be carried out by the firm in its jurisdiction, prior approval the department shall be taken and design shall be subject to the approval of this department.
- 3 The usage of water of Lingti khad shall be handed over to the second party purely on temporary basis and the company/firm shall have no permanent right on it.
- 4 The joint inspection of site of Hydro Electric Project Lingti SHEP 0.50 MW was conducted on 13/07/2011 by Assistant Engineer, I&PH Sub Division, Palampur with Junior Engineer of concerned section along with representative of the firm.
- 5 That the IPH department has power to stop the construction work of Binwa SHEP (5.00 MW) electric power Project, if any on going scheme is disturbed/effected by the company/Firm during the construction of the project.
- 6 If any private kuhl is disturbed / effected due to execution of this project the project authority has to talk with the beneficiary of Pradhan Gram Panchyat concerned and K.V.S for the its alternative arrangement.
- 7 If any WSS or irrigations scheme and water mills on upstream and down stream of Project is submerged/distributed due to construction of this project the project authority will have to pay the full compensation claim for that as per estimate sanction by the department and will have to deposit the original cost of scheme including its remodeling, restoration and augmentation cost as the case may be.
- 8 This department reserves the rights flow in future as much quantity of water as required from the concerned Khad to formulate and execute any WSS or Irrigation scheme.
- 9 The projects shall be based on "Run Off" condition. There should not be any diversion and poundage facility which may affect natural water flow condition in upper stream and down stream of Khad.
- 10 The Chief Engineer (N^o) I&PH Department, Dharamshala shall be the sole adjudicator for any dispute arising during construction as well as subsequently and his decision shall be binding on all the parties.
- 11 That in case there is any scarcity of water due to drought or any other reasons, the requirement of department shall have precedence over the requirement of the Hydro Electric Power Project.
- 12 The Proposed will not infringe the drinking rights on upstream or downstream of the project of I&PH Department.
- 13 The second party shall furnish to the first party a compendium giving details of hydrological data/observation within one year of signing of MOU.

14 The Second party will not dump blasting muck and soil etc. on the project site or any other in appropriate place, which flow further to down stream of the khad causing serious threat to the existing water supply or Irrigation scheme of H.P I&PH Department.

15 A forum of Hydro power producers of Beas based has come into existence on 05-11-2005. The guideline of this forum whatever applicable, the attempt will be made to abide by the recommendation of the forum and applicable to second party. If however any such more forum are constituted for other river basin the guidelines of the same shall be applicable on second party.

16 The second party shall ensure to project the water rights of the local inhabitants for drinking and irrigation purposed etc, by verifying the revenue entries and activities of IPH department so as to ensure that such rights are not infringed upon, any dispute in the mater shall be referred to a committee, to be appointed by the First party involving IPH and revenue department. However the decision of the first party shall be final and binding on all the parties.

17 The first party shall put in place a committee comprising of experts from the relevant field for determination of the impact, if any, on the existing water supply or irrigation projects due to allotment of any upstream and/or down stream project. In the event of a dispute the decision of first party in the matter shall be final and binding on all the parties.

18 The second party shall ensure minimum flow of threshold value of water not less than 15% of the minimum flow observed in the lean season immediately down stream of the project all the time including lean season from November to March. Keeping in mind the serious concern of the state government on account of its fragile ecology environment and also to address issue concerning riparian rights, drinking water etc & even to honor the sensitive religious issue like cremation and other religious rites etc. On the right bank of the khad, the second party is at liberty to install mini hydro project to harness such water for their captive use, utilities system and other purposes.
