Subject: No Objection Certificate (NOC) for establishment of retail outlet (Petrol Pump) at proposed location i.e. Bhiwani city between Meham Gate to Haryana Parkartik Chikitsalaya on Bhiwani Meham road village Kaluwas Tehsil & District Bhiwani.

Reference: Your office memo. No.634-41/PLB dated 11.03.2016.

The NOC case for the work cited as subject received vide your letter under reference is returned herewith. There is No Objection to issue the NOC to the above said retail outlet with the following conditions :-

1. The company will provide a one meter width Hume Pipe culverts on both the approaches.
2. The company will not construct katcha or pucca structure on the PWD land.
3. Level of approaches should be kept below the shoulder of the PWD road level.
4. The company will regulate the storm water drainage to avoid damage to the road.
5. The company will supply agreement deed separately to the deptt. for execution of agreement for lease of Govt. land.
6. The company will arrange the drainage of the area of retail outlet in such a manner so that its storm water does not flow on the PWD land in any case.
7. The Longitudinal drainage of the road should not be affected in any manner.
8. The company will not provide any sign board or hoarding which violates the instructions of Hon'ble High Court and Hon'ble Supreme Court.



10. The rent for lease charges of land has been deposited vide SDE, Provl. Sub Divn. No. 1, Bhiwani G.R. No. 000067/4922 dated .02.05.2016 amounting to Rs.80,000 (Rupees Eighty thousand only) for 15 years & thereafter the rent for next fifteen year will have to be deposited regularly and the concern agreement has been made with this department (Copy of the same is enclosed herewith). If any charges occurs on this part time to time will also be applicable on the agency.
