Ref:- In continuation of this office letter No 1369 dated. 13/12/2016

In respect of above said subject reference it is intimated that this office has received the DD No906433 dated 29/12/2016 amounting to Rs. 51,564/- and BG amounting to Rs. 22,00,000/- on dated 13/01/2017 against B.T.Bill which is issued by this office vide memo under reference . You are also directed to start the work under the intimation of Sub Divisional Engineer, Central Works Sub Division No.1 Hoshiarpur trenchless method/open trenches on Shri. Hargobindpur to Tanda (NH 503 A) is hereby granted subject to following conditions:-

1. If River Nallah bed is dry, M/s Reliance Jio is proposed to cross the cable by laying G.I/RCC pipes at 1.65 mtr below the river bed in case of flowing water where M/s Reliance Jio Infocomm Ltd can not cross by horizontal directional drilling method, the same (Bridges/Canal) will be crossed by clamping method.
 - i. If clamping method is not possible, bridge will be crossed by concrete incased G I Pipe laid inside the railing on the edge of the bridge.
 - ii. All link roads will be crossed by auger boring or using trench less method incase there is any difficulty at particular crossing M/s Reliance Jio Infocomm Ltd will contact with the departments' concerned Engineer before taking up the work.
2. The deptt. shall not be responsible for any loss or damages to the cable etc. that may occur due to any reason during/after laying the same.

3. In the event of any mishappening/ accidents etc. while carrying out laying of cable, M/s Reliance Jio Infocomm Ltd shall be liable to pay any type of compensation so claimed.
4. M/s Reliance Jio Infocomm Ltd shall not cause any damage to the carriage way of the highway and the structures like bridges, culverts, drains, buildings etc, and in case of failure the M/s Reliance Jio Infocomm Ltd will be liable to make good the loss caused to the deptt.
5. M/s Reliance Jio Infocomm Ltd shall lay any the cable only under the guidance of the deptt.
6. The deptt. shall not be responsible in case of the cable line comes in the area under development in future at any time. In such an eventuality, shifting of the cables etc, shall be the liability of the M/s Reliance Jio Infocomm Ltd.
7. M/s Reliance Jio Infocomm Ltd shall be responsible for any damage caused to the trees in the PWD boundary . It will be responsibility of M/s Reliance Jio to obtain permission for any such likely foreseen/ unforeseen damages from the competent authority.
8. In case of some un-available circumstances if M/s Reliance Jio Infocomm Ltd desires to across the Carriage way, the same shall be done under the guidance of the deptt. and under no circumstances, the carriage way shall not be allowed to be damaged. The crossing of carriageway shall be allowed with pressure augers only.
9. While crossing the bridge/culverts no additional dead load shall be allowed to be added to the existing structure.
10. The work will be executed under guidelines/ supervision of the Executive Engineer, Central Works Divisions Hoshiarpur/ Sub Divisional Engineer, Central Works Sub Division No 1, Hoshiarpur. .
11. The cable will be laid only after the Bank Guarantee has been deposited and the agreement has been signed.
12. The clauses of the Agreement conditions should be strictly followed.
13. The period of validity of right of way permission shall be terminus with the validity of license.
14. In case any shifting or alternation in the position of the laid telephones, cables is required due to widening of highway and construction of flyover bridges, you will do the same at your own cost at a later date within specified period.


15. You shall ensure safety and security of all under ground installation/utilities/facilities and shall be solely responsible for compensation indemnification for concerned authority for damage caused/claims or replacement sought for at the cost and risk of you.
16. You will be liable to give a notice of 15 days with route details to trenching for fresh or maintenance/ repair work. A separate performance Bank guarantee for maintenance repair work shall be furnished by your
17. Your will submit two sets of as built drawings showing the exact location/ distance from ROW and depth properly where cable has been laid to this office after completion of work within three days.
