In exercise of powers vested in me by Department of Urban Development Himachal Pradesh Shimla vide Order no. UD-C (10)-1 2014-I-Loose dated 21-04-2018 the Administrative Approval & Expenditure Sanction amounting to Rs. 2,77,81,743.00 (Rs. Two Crore Seventy Seven Lakh Eighty One Thousand Seven Hundred Forty Three only) is hereby accorded for Sewerage Treatment Plant based on root zone treatment technology for the area of Naddi.

Source of Funds : Smart City Fund

The expenses incurred on the works shall be debited under AP 18- Adequate and efficient Sewerage, Sub Head-18.2- SCADA

The AA&ES is subject to the following terms and conditions:

1. The Administrative Approval and Expenditure Sanction is subject to technical approval from the competent authority and it shall be ensured that the technical sanction is obtained as per CPWD/HPPWD/I&PH manuals.
2. The work shall be executed after completion of all other codal formalities as per guidelines of Smart City Mission.
3. No excess expenditure is allowed above AA/ES accorded.
4. The work should be awarded to those firm/bidder who possess the valid EPF & GST number.
5. It shall be ensured that there is no deviation in the award cost while executing the work.
6. It shall be ensured that only those contractors who possess the EPF registration number & have regularly filed EPF returns for the preceding two years be only allowed to participate in the bids. These EPF returns shall be evaluated to ascertain the eligibilities criteria of bidders.

With reference to the letter no. 15908, dated 28/01/2022 received on date 28/01/2022 from the Executive Engineer, Jal Shakti Sub Division, Dharamshala, Tehsil Dharamshala, Distt. Kangra, H.P. along with the revenue record vide which they have applied to get the land as tabulated below:

As per the above tabulated record provided the land is to be transferred in favour of Jal Shakti Vibhag, Govt. of H.P. for the construction of Septage Treatment Plant.. The State Pollution Control Board has no objection if the said land is transferred in favour of Jal Shakti Vibhag, Govt. of H.P. subject to the following conditions:

- (viii) Prior consent of the State Board shall be obtained before undertaking any steps to establish the project under Water Act, 1974 and/or Air Act, 1981, as the case may be.
- (ix) Transfer of land shall be governed only by the regulations and provisions prescribed by Revenue Department and this NOC alone shall not entitle the applicant to purchase/acquire land.
- (x) NOC so issued shall not confer any right on the applicant to establish the project unless the Revenue Department has actually allowed the acquisition of land.
- (xi) This NOC is subject to prior forest clearance, if any required.
- (xii) The proponent shall maintain noise level equal to or less than the standard prescribed under Env. Protection Rules, 2016 for sensitive areas near its boundary walls.
- (xiii) The project shall provide proper scientific system for the disposal of domestic effluent, kitchen waste water and Municipal Solid Waste.
- (xiv) During the plot leveling if any muck is generated, the same should be stored/stacked/back filled scientifically alongwith the provision of toe walls, as required.

**RECLAMATION PLAN
FOR CONSTRUCTION OF SEWERAGE TREATMENT PLANT AT NADDI IN MOHAL
NADDI, TEHSIL DHARAMSHALA, DISTRICT KANGRA (H.P.)**

The muck produced from all the components would be self utilized with due consideration of its distance from the component, suitability of the area and Topography point of view.

Rehabilitation Proposal

Since there is no displacement of any population due to the construction of the Sewerage Treatment Plant, there will be no rehabilitation problem.

Afforestation

Compensatory afforestation shall be carried out by the forest department for which compensation shall be paid by the user agency. Compensatory Afforestation shall be carried out in double the degraded forest land of the area proposed for diversion.

Retaining walls

RR Masonry / GI Wire crate filled with boulders/ stones reclaimed from excavation of various project components shall be used for construction of retaining walls for retaining the surplus excavated earth / muck as per standards adopted with due consideration to site condition.

Use of muck/debris

The entire muck/debris obtained from the project components shall be used for manufacture of aggregates for construction work, filling in wire creates, stone masonry works, breast wall, etc.





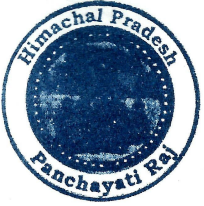
