Sub: Request for grant of Right of Way Permission for laying Optical Fiber Cable along the route from Water pump house near grain market FatehgarhChurian to near Post office Ajnala via AjnalaFatehgarhChurian road and SH 25 Ajnala(CH.00-CH.21271) (Total Length21.271 Km) on routeAjnala-FatehGarhChurian(Link ID -1.2.22). The RoW is required for a period of 10 years to sustain life of Net Work considering Security aspects of Nation as mentioned in the Tender of Army.

Dear Sir,

Indian Army intends to rollout Optical Fiber Cable Network Army Static Switched Communication Network Phase-IV(ASCON-Phase-IV).

To execute this project, The Indian Army has issued Purchase Order to ITI Ltd (ITI is Project Implementing Agency), ITI Ltd has further issued Tender to M/s Vindhya Telelinks Limited to execute this project. We are enclosing letter of Authorization issued by Army to ITI and further, letter of authorization issued by ITI to us as Annexure-I & II to this letter.

The work will be executed by M/s Vindhya Telelinks Limited an authorized Service Partner of ITI Limited (The End User Is Indian Army) through HDD method and as per standards, policies and guidelines laid by you for laying the OFC Cable. In this HDD (Trenchless) method with pits generally of dimension 1.5m X 0.60m X 0.45m at the average interval of appx 150 meter. We would request you to accord permission for lying of this network in exclusive corridors (i.e. wherever less utilities of other operators)..

OFC link in above mentioned section, falling under your jurisdiction is also required to be rolled out as part of this project.

We request you to issue BT Bill/Demand notes in favor of Directorate General of Signals, General Staff Branch, Integrated HQ of MoD (Army)DHQ PO New Delhi-110011 and C/O Vindhya Telelinks Limited, E-237, Industrial Area, Phase 8-B, Mohali, Punjab-160068, which is solely the executor of the project. Please note the payment of the said BT/DD Bill will be made by Vindhya Telelinks Limited.

As per terms and condition of Army Tender floated to ITI, RoW permission should be obtained for a period of 10 years. So you are requested to kindly arrange to issue Right of Way (RoW) Permission for 10 years for maintenance of this critical OFC network sought by us, at the earliest to ensure implementation of project in time bound manner.

We are enclosing herewith all the requisite documents for the permissions to lay the Optical Fiber Cable along with Route Diagram for your perusal.
