The Joint Inspection of the proposed site for **C/O Himachal Pradesh Technical University campus, Hamirpur, Distt. Hamirpur (H.P)** for diversion of forest land under Forest Conservation Act, 1980 section 2 is conducted on dated **2.04.2024**. In this project total **24.0187 hectares** of Forest land is involved. However all effort have been made for avoidance to forest land but as per topography and site condition, above forest land measuring **24.0187 hectares** involved in the above project is barest minimum and cannot be avoided.

The Joint Inspection team has examined all the alternatives with a view to avoid/minimize the use of forest land and come to the conclusion that the proposed land is the minimum requirement of the proposed project and the diversion of this patch of forest land is absolutely essential. There is no natural water resource, cremation ground, common purpose infrastructure etc. in the proposed site/ land.
