In inviting a kind reference to the subject & letter under reference, it is resubmitted herewith the diversion proposal after compliance of the following discrepancies/ shortage as noted below.


1. All the documents submitted with the proposal is now ink-signed.
2. The compensatory afforestation will be done in Rekhapali Mouza of Malkangiri District in Khata No-88 and Plot No-645, revenue forest kissam to the extend of land in 10.8 Ha.
3. Copy of letter of Govt of India regarding cost of the project (rs. 277.05 crores) is now furnished herewith.
4. Cost benefit part of the proposal is now furnished in the booklet.
5. Part-II of the proposal is now left Blank for your observation / remarks.
6. The DGPS map prepared by ORSAC may kindly be authenticated.
7. The project area shown on the cadastral Map is total in R.F. as intimated by the Tahsildar, Baipariguda vide his letter no 1751 dated 21.04.2017 (copy enclosed).
8. The land schedule is not required as the total diverted area are in R.F, as intimated by the Tahasildar, Baipariguda vide his letter under reference is tem no-7.
9. The co-ordinates of the road at the beginning is N 18 41' 10.9" E82 22' 20.9" and at the end of Jeypore Forest division is N18 38'45.8" E82 20' 17.8".

11. (a) The certificate required under Forest (Right) Act 2006 with the supporting documents will be issued by the PA, ITDA, Jeypore for SDLC for which the Letter No 808 (w/e) dt 17.4.2017. of this office may be referred.




