NHAI has been entrusted with the subject project and its upgradation to 2 lane with paved shoulder involves diversion of forest and non-forest land. Accordingly, Forest Diversion Proposal (FDP) was submitted online on 02.02.2022 vide proposal no. FP/HP/ROAD/151932/2022.


