** 65.85 Ha of State Land comes under riverbed and it is not to be acquired but royalty has to be paid.

The project affected families are mainly from Bhagna (Padyarna) and Semna Bhata villages. One PAF of Bhagna (Padyarna) village is losing 0.04Ha of land in Dichla village also. The rest of the land (11.85 Ha) at Dichla village comes under river bed. In Ajna village, 4 no. of Kothas are going to be affected on river bed land. In case of Galhar Bhata, all the affected land (5.15 Ha) is river bed land. No structures of families are going to be affected in this village.

12.3 IDENTIFICATION OF PROJECT AFFECTED VILLAGES AND FAMILIES

On finalization of the project layout, land required for the project was marked on the map of the area, which is prepared for the purpose of the project development by undertaking the topographical survey. This requirement is transferred on the revenue map (latha) of the area available with the local authorities (Patwari). Khasra numbers have been identified for the land required and ownership information was collated from the written revenue records. As the local records are all made in Urdu, they were translated in English and used for compiling the list of owners for the identified land for the Project. As can be seen from the land requirement Table above (Table no 12.1 & 12.2), 87.51% of the land required for the project belongs to State Government and Forest Department and only remaining 12.49% has private owners. Project authorities have made an attempt through surveys to identify the private landowners and structures coming under acquisition.




Figure 12.1: Location map of project components
