Subject: Construction of New 2 Lane with Paved Shoulder of Hamirpur Bypass of NH-88 (New NH-103 & 03) (Design Chainage-Km.121+175 to Km.138+295, Design Length-17.120 Km) in the State of Himachal Pradesh - Forest Diversion Proposal Reg. (Online Proposal no. FP/HP/ROAD/151932/2022).

Sir,

Kindly refer to the online proposal no. FP/HP/ROAD/151932/2022 for diversion of 2.7856 Ha. forest land for the captioned subject which was uploaded on 2nd Feb, 2022 and few observations were received from the Nodal Office (FCA, H.P) vide letter dated 11th February, 2022 as cited under reference above. The point-wise compliance to these observations is submitted as under.

1.	In part-I, against column No.A-1(x), the total period for which the forest land is required (in years), '0', has been mentioned. The period for which forest land is required to be mentioned against this column and 99 years is required to be mentioned against this column.	Needful has been done.
2.	Against column No.B-2.3 in online part-I, although the village wise breakup has been mentioned. But as per Gol instructions the certificate is required to be submitted as an essential document with the proposal on the prescribed format of Gol. Further the total of non forest land is coming 60.3013 ha. instead of 60.3014 ha.	The Certificate (providing detail of villages) from the Sub-Divisional Officers-Cum- Competent Authority for Land Acquisition Hamirpur & Nadaun have been obtained on the prescribed format and has been uploaded against the additional information details. Due to change in the alignment, the total non forest land has now been revised to 60.5080 Ha. and the same has been updated in the portal.
3.	Against column B-2.4, in the detail of components only one component proposed bypass has been mentioned. Against this column the components of the proposed road i.e, the land required for road and for dumping sites is required to be	Needful has been done



4.	Against column No.C(ii)(b), in the uploaded KML file, the proposed bypass has not been shown. As per GOI instructions, the KML file, showing the dumping sites, alternate alignments, if examined and villages to be benefitted from the proposed road are also required to be shown.	The revised kml has been uploaded in the portal.
5.	Against column No.E(ii), '20' and against E(iii), '73000' has been mentioned. It is required to be clarified by the user agency that 20 regular employment will be generated from the construction of the said widening. Necessary corrections are required to be made in the employment details mentioned in online.	The necessary corrections are made in the employment details mentioned online.
6.	Against column No.I(i), 'No' has been mentioned. As per latest instructions of GoI, in case of "No", the distance from the protected area or their Eco sensitive zone is required to be obtained from DFO concerned for uploading against additional information details.	The distance from the protected area or their Eco sensitive zone is obtained from DFO (WL) Hamirpur and uploaded against additional information details.
7.	Muck Management Plan is also required to be uploaded against additional information detail	There is no tunnel in this project. However, disposal plan for excess earth quantity generated from the project is uploaded against the additional information details.
8.	Certificate of non availability of non forest land for the project in question is required to be obtained for further processing the proposal for uploading against additional information detail.	A letter has been submitted to DC Hamirpur for issue of Certificate of non availability of non forest land and an undertaking by the User Agency to obtain the same is also uploaded against additional information detail.
9.	Document showing the length and width of the proposed widening is required to be uploaded against additional information detail.	The document showing the length and width of the proposed road in forest and non forest land is uploaded against additional information detail.

In addition to above, due to change in right of way, the diversion of forest land and non-forest land has been revised to 2.4329 Ha and 60.5080 Ha respectively.

Therefore, the forest proposal for the subject project has been revised and uploaded in compliance to the requirements of the Nodal Office (FCA, H.P) for further processing of the proposal.
