In this regards, I am to state that the user Agency Oil & Natural Gas Corporation Ltd. has already deposited an amount of Rs. 21,30,166/- being NPV, Compensatory Afforestation and over head cost (70%) in the form of Demand Draft in favour of Chief Conservator of Forests & Nodal Officer, O/o the Principal Chief Conservator of Forests & Head of Forest Force, Assam alongwith an undertaking to pay additional amount of the NPV of the diverted land as per point No. (iii) of MoEF letter dtd. 22-12-2011.
