Sub: FC Act.1980 - Diversion of Forest land in compartment no. 393 of Ravoor RF and compartment No. 392 of Ramayapatnam in Giddaluru Division for laying Petroleum pipelines with OFC from Krishnapatnam -Hyderabad pipe line project in favour of BPCL - Enumeration and loss of value report submitted - Regarding.

It is submitted that, the head office vide reference 1<sup>st</sup> cited advised to take up enumeration of the existing species in the proposed alignment of the multiproduct pipe line passing through our plantations in Ravoor and Ramayapatnam RF area and to arrive the compensation amount as per the procedure. In this regard the same was communicated to the Divisional Manager Kavali North and the Divisional Manager Kavali North has submitted a detailed report on enumeration and the Compensation amount vide reference 2<sup>nd</sup> cited.

The Divisional Manager, Kavali North reported that the proposed trench of Bharat petroleum pipe lines will pass through 2014, 2016 & 2017 Ravoor Eucalyptus Clonal plantation raised by the APFDC Ltd, Kavali North Division in Ravoor Reserve Forest. The length of the proposed trench & Bharat Petroleum pipe line in APFDC plantations is 1770 mtrs. and 1.65 Ha. (2014 Ravoor-0.12 Ha+ 2016 Ravoor- 0.43 Ha. + 2017 Ravoor 1.10 Ha.=1.65 Ha.).

The Divisional Manager, reported that 2014, 2016 & 2017 Ravoor Eucalyptus clonal plantations are due for 1<sup>st</sup> rotation harvesting. As per the enumeration report of Divisional Manager 3505 trees are existing under the proposed alignment. The standing growth of 1<sup>st</sup> rotation has to be converted into Eucalyptus pulpwood before handing over the area. Since, the plantation is not sold so far the Divisional Manager, Kavali North has assessed the loss of crop and the compensation amount to be collected from user agency as Rs.14,77,946/- as detailed below.

Further the Divisional Manager Kavali North, reported that the expenditure required for enumeration and conversion charges of Eucalyptus clonal is Rs. 2,36,119/- . The details are shown below.

In total, an amount of Rs. 14,77,946/- ( Rs. 12,41,827/- Revenue loss + Rs. 2,36,119/- Expenditure for conversion) compensation amount is arrived for 1.65ha.
