a.	The Right of Way to access road to the temple is mentioned as 818 metres in the RF notification whereas actual distance in the field is around 1200 metres. It was informed by the Field officials that the alignment of road was changed in due course, due to the slope of area and for the requirement of movement of vehicles during monsoon period. Hence requirement of area for using the road in addition to the RoW mentioned in the RF notification needs clarification.	•	I submit that Right of Way in Serial no.3 is 818 metres and in Serial no.4 is 434 metres in the RF notification and the total approximate distance is 1200 metres. Hence, I clarify that there is no requirement for additional road other that RoW in RF notification.
b.	As per the temple authorities the original temple was constructed with old rubble masonry wall around the temple. But additional concrete building block (1298 sq ft as per DSS estimate) was constructed in northern boundary and a small pump room (59 sq ft as per DSS estimate) was also constructed but its year of construction is not known to the officials. It needs to be confirmed	·	I submit that the additional concrete building block (1298 sq ft as per DSS estimate) inside the temple premises was totally damaged and hence repairing and white washing work was carried out. The small pump room (59 sq ft as per DSS estimate) was a temporary structure which was constructed long back.
C.	The temple authorities informed that due to the large numbers of Pilgrims being visited during the festival seasons some area in the southern portion was utilized temporarily (0.15 Ha as per the DSS estimate).
