(Copy of undertaking enclosed) Hence, it is more specifically clarified that Hon'ble high court vide order dated 08.12.2020 (Page no. 7, Para no. 4) directed NHAI to "submit affidavit after FCA permission in respect of payment of compensation amount if judgement of court comes in favour of local people". Hence in compliance of Hon'ble High Court direction dated 08.12.2020 undertaking/affidavit will be submitted
