3	The State Government may submit upload the CA scheme mentioning the name of the CA area.	Mentioning the name of the CA area Reserve forest chhira compartment No-24 in CA scheme has been uploaded in online Part-I
4	The text of CA site suitability certificate is confusing. It is seen that civil soyam land is mentioned in the CA site suitability certificate. However, the CA is proposed in forest land. The State Government may review the same and submit upload the correct CA site suitability certificate.	Corrected CA Suitability Certificate mentioning CA Area proposed in degraded forest land at reserve forest chhira compartment no. 24. And uploaded same in online Part-I
5	Tree enumeration list of 603 trees is uploaded at para-4 in Part II. However, list of 593 trees is submitted in hard copy. It seems that enumeration in civil soyam land is not provided. The State Government may remove this discrepancy and provide correct information both online and in hard copy.	Actual effected numbers of trees are 593 and same mentioned in hard copy. And also corrected in online Part-II.




