	HAND MIRE TO COVING AND MIRE WITH A PROPERTY OF THE PROPERTY O	While uploading of Forest diversion proposal in the portal, the total forest and non-forest area is revisited by the project proponent and surveyed accordingly. After detail survey and georeferencing with the help of GIS based software and available authenticated land schedule, it was found that the forest area comes around 549.48 Ha. and non-forest area is 917.94 Ha. instead of forest area 517.95 Ha. and non-forest area as 949.47 Ha. mentioned in the approved Mine Plan. Thus, total forest area of 549.48 Ha. out of total project area of 1467.42 Ha. may be considered for forest diversion under section 2 of the Forest (Conservation) Act,1980. It may kindly be noted that as per the office memorandum F.No -34011/28/2019-CPAM dated 29th May 2020, clause 1.3 (B) of Ministry of Coal, Govt. of India "Notwithstanding anything contained in clause (A) above, for other minor changes, the project proponent is empowered to make modification with the approval of the respective company board. These minor changes shall cover (a) changes in land type within the leased area; (b) changes in HEMM deployment plan; and (c) changes in location of infrastructure within the leased area. The project proponent shall submit specific report of such minor changes to coal controller, CCO, Kolkata with a copy of the same to Administrative Section dealing with the allocation/allotment of the block and section dealing with approval of Mining plan at MoC/CCO for information". Therefore, the changes in respect of forest, non-forest area after vetting at DFO level shall be treated as minor changes and the project proponent will submit specific report after finalization of total forest, non-forest area within the lease to coal controller, CCO, Kolkata with a copy of the same to Administrative Section dealing with the allocation/allotment of the block and section dealing with approval of Mining plan at MoC/CCO for information.
