1. Execution Partners must ensure following:
1. Assess the work place with respect to probable electrical hazard and necessary precaution to be taken to prevent electrocution, as per Indian electricity act & rules.
2. Strict compliance of use of personal Protection Equipment (PPE) by all the workers / supervisors (full body harness, safety shoes, jackets, helmets, hand gloves, face shield, gum boots, etc.).
3. Always practice to draw power using 3-pin switch / socket for all power tools without any joints in power cables.
4. Installation of hard barricades surrounding the erection / material lifting area with adequate warning boards to restrict the unauthorized entry.
5. Always use insulated tools & tackles with proper grounding of the power distribution boards.
6. Proper illumination and lighting arrangement for working in darkness.
7. Deputation of trained & experienced supervisor at work place.
8. Ensure to discharge the HT power line after confirmation of disconnection from local authorities in case of shut down, before starting of work.
9. Work permit system to be strictly implemented as per applicability treating all electrical cables / conductors as live unless tested otherwise.
10. Strict use of non-conductive ladders, calibrated as well as insulated tools & tackles.
11. Emergency contact numbers and fully equipped first aid box must be easily accessible at work site.
12. Awareness of HSEF guidelines and SOP's is very much required to be created among workers during tool box talks at site.
13. Any accident which takes place due to lapses or negligence on the part of the vendor, must be dealt with severely. Fatal accident will be treated as an offence and will warrant suitable punitive action to the extent of black-listing of the vendor.
14. Always maintain specified minimum separation, as mentioned below from overhead or exposed power lines while working:
